1. Discussion Item: AS/ Academic Affairs Resolution on Generative AI (Aligned with CSSA)

Email Responses

- Did their dean/department respond?
- What patterns emerged across the questions (disclosure, detection, privacy, equity, usage)?

Identify Consensus & Gaps

- Where do colleges *agree*?
 - These become your strongest WHEREAS clauses and BE IT RESOLVED points
- Where do colleges *disagree or lack policy*?
 - These become the problems your resolution directly addresses
- Were there non-responses?
 - That itself is data worth noting

Draft Core Resolution Language

- **WHEREAS**
 - clauses from outreach findings + CSSA white paper data
- **BE IT RESOLVED**
 - statements reflecting your non-negotiables
 - (due process for AI detection, privacy disclosure, equity access, etc.)
 - Flag any items still needing committee decision
 - (how prescriptive the baseline should be vs. department flexibility)

2. Discussion Item: Potential Partnership with Gray Decision Intelligence (GDI)

Background

- I met with Adam Wrede, a Business Developer for GDI, to explore a potential partnership with SJSU
 - provides decision intelligence tools that connect academic programs, labor market analytics, and career outcomes to support workforce alignment and student decision making

Why This Could Matter for Students

- Clearer insight into what careers connect to each major
- Better data on job trends, salaries, and in-demand skills
- Stronger alignment between what we study and what employers are looking for
- Potentially improved career readiness and post-grad outcomes

Discussion Questions

- What student need would this actually solve?

- Would this improve advising and career planning in a meaningful way?
- How is this different from tools we already use (Handshake, career center resources, etc.)?
- Would students realistically use it?
- Should this be tested as a pilot first?
- Is this something we should bring to the President's Cabinet for consideration?

Possible Next Steps Request a student-focused demo of the platform. Gather feedback from students and advisors. Decide whether to formally recommend it to the President's Cabinet!
